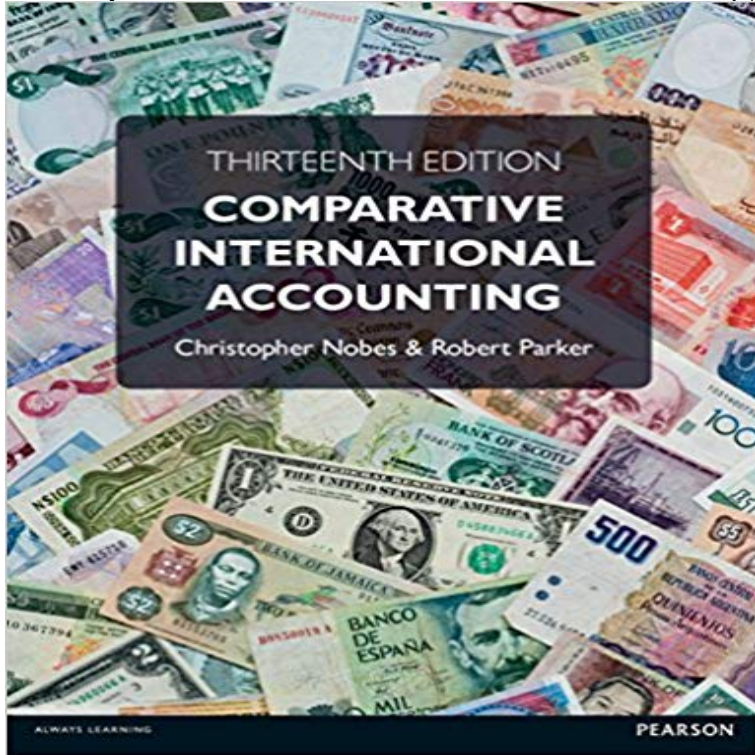


# Comparative International Accounting
